ORDINANCE ESTABLISHING THE 3-S IN VALENZUELA CITY AND PROVIDING PROGRAM IN THEREFOR.

WHEREAS, there is a need to continuously formulate program and initiatives that are efficient, accessible and easy to implement, to make certain that all business processes in the City go as smoothly as possible;

WHEREAS, the Office of the City Mayor through the issuances of Memorandum No. 2011-006 which streamlined the Wayor's and/or Business Permits and Licenses Application as well as the implementation of the 3-S in Public Service Program in all areas of business registration and licensing procedure in Valenzuela City;

WHEREAS, there is a necessity to formally institute the 3-5 Program which stands for, SIMPLE, SPEED and SERVICE, in order to make it easier for business registration and licensing procedure in Valenzuela City and to further strengthen the delivery of services to the constituents on a long term basis;



It is bereby formally instituted a program that offers a fast, efficient service that allows business to be up and running in no time and is designed to hasten the business related application processes to ensure comfort and convenience of taxpa pers and guarantee high quality service to be known as the 3-S in Public Service Program in Valenzuela City. The 3-S in Public Service in Valenzuela City shall stand for: 1. SIMPLE process; CV2. SPEED in deliveryprocess and procedures; and 3. SERVICE excellence STEPS IN DOING BUSINESS IN VALENZUELA CITY. SECTION 4. Before starting any type of business in Valenzuela, a business license must be first secured, certifying that the operations and transactions are legal and legitimate. Doc After securing a business ligense, registrants are assumed to have complied and will continue to comply with all the Post-audit requirements. An inspection shall be conducted within a month following the release of the business license to ensure full compliance.
