A RESOLUTION DECLARING UNDER THE STATE OF CALAMITY THE TWENTY FIVE (25) BARANGAYS IN THE CITY OF VALENZUELA NAMELY: FOR DISTRICT I - WAWANG PULO, BALANGKAS, PARIANCILLO VILLA, POBLACION, PALASAN, ARKONG BATO, PULO, ISLA, BISIG, TAGALAG, MABOLO, COLOONG, MALANDAY, PASOLO, DALANDANAN, RINCON, MALINTA, VEINTE REALES, LINGUNAN AND CANUMAY WEST; FOR DISTRICT II - MARULAS, GEN. T. DE LEON, KARUHATAN, PARADA AND MAYSAN.

WHEREAS, Republic Act No. 10121 entitled: "The Philippine Disaster Risk Reduction and Management Act of 2010", provides that provinces, cities, municipalities, including cluster barangays, may be declared under the State of Calamity through the local sanggunian, upon recommendation of the Local Disaster Risk Reduction and Management Council (LDRRMC) based on the results of the damage assessment and needs analysis;

WHEREAS, Section 458 (1)(iv) of R.A. 7160 provides that the Sanggunian shall adopt measures that will protect the inhabitants of the city from the harmful effects of manmade or natural disaster or calamities and to provide services and assistance for victims during and in the aftermath of said disaster or calamities and in their return to productive livelihood following the said events;

WHEREAS, due to continuous heavy rains brought about by typhoon "Maring" submerging twenty five (25) Barangays in the City, thereby causing irreparable damage to houses and other properties and disruption of means of livelihood; hence residents of the said barangays are in need of immediate assistance in terms of food, shelter, clothing and other basic services;
