



INVITATION TO BID

FOR THE REHABILITATION/WIDENING/DESILTING/CLEARING OF MARULAS CREEK

1) The City Government of Valenzuela, through the **Flood Control System Local Disaster Risk Reduction & Management Fund Res. No. 2025-007 Dredging, Widening & Rehabilitation of Waterways** intends to apply the sum of **FORTY MILLION FOUR HUNDRED NINETY-NINE THOUSAND FIVE HUNDRED SEVENTY-TWO AND EIGHTEEN HUNDREDTHS (PhP40,499,572.18) (BC# 70; Ref. No. 25-728)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Contract Reference No.: 078-REHAB/WIDENING/DESILTING/CLEARING MARULAS CREEK-MAR-LDRRMF-INFRA-2025**. PCAB MIN. REQUIRED SIZE RANGE/CATEGORY **Medium A**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2) The City Government of Valenzuela now invites bids for the **Rehabilitation/Widening/Desilting/Clearing of Marulas Creek (from Mc Arthur Hiway to F. Bautista) Brgy. Marulas, Valenzuela City**. The contract will be awarded to the **Lowest Calculated Responsive Bid (LCRB)**. Contract duration is **180 calendar days from receipt of Notice to Proceed**. Bidders should have completed, at least 10 years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.

i. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
