



**INVITATION TO BID**

**FOR THE PURCHASE OF 2 UNITS WATER HYACINTH HARVESTER FOR PUBLIC SANITATION AND CLEANLINESS OFFICE-FLOOD CONTROL DIVISION**

- 1) The City Government of Valenzuela, through the **Disaster Response & Rescue Equip. Res. 2025-005-Local Disaster Risk Reduction & Management Fund** intends to apply the sum of **TEN MILLION (PhP10,000,000.00) (BC# 71; Ref. No. 25-130)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Project Reference No.: 129-WATER HYACINTH HARVESTER-PSCO/FCD-LDRRMF-GOODS-2025**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The City Government of Valenzuela now invites bids for the **purchase of 2 units Water Hyacinth Harvester for Public Sanitation and Cleanliness Office-Flood Control Division**. The contract will be awarded to the **Lowest Calculated Responsive Bid (LCRB)**. Delivery of the Goods is required within **60 calendar days from receipt of Notice to Proceed**. Bidders should have completed, at least 10 years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.
  - i. Bidding is open to all interested Bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR.
