AN ORDINANCE APPROPRIATING THE AMOUNT OF BILLION NINE HUNDRED MILLION (₱5,900,000,000.00) AS THE EXECUTIVE BUDGET TO BE MADE AVAILABLE AS APPROPRIATIONS OF THE CITY GOVERNMENT OF VALENZUELA, METROPOLITAN MANILA, TO BE TAKEN FROM THE INCOME CERTIFIED REASONABLY COLLECTIBLE BY THE TREASURER FOR THE CALENDAR YEAR 2025.





#### **SECTION 2. BUDGETARY REQUIREMENTS.**

The budgetary expenditures herein proposed shall comply with the following requirements:


The aggregate amount appropriated shall not exceed the estimates of income.

Full provision shall be made for all statutory and contractual obligations. REVIEWED

Aid to barangayst in http://www.mount of not less than ONE THOUSAND

PESOS (P1,000.00) shall be provided and shall be released immediately upon approval of this Ordinance as augmentation for barangay operations and/or projects. RUBY P. MURO

Five percent (5%) of the estimated revenue from regular sources shall be set aside as an annual lump sum appropriation for unforeseen expenditures arising from the occurrence of calamities provided that such appropriation shall be used exclusively in the territorial jurisdiction of the City Government of Valenzuela, Metropolitan Manila or other areas declared in a state of calamity by the President. Any amendment and augmentation may be made within the calendar year only upon the enactment and approval of a Supplemental Budget Ordinance.

#### **SECTION 3. GENERAL LIMITATIONS.**

The total appropriations for personal services for Calendar Year 2025 do not exceed the forty five percent (45%) budgetary limitations of the total annual income from regular sources realized in the next preceding calendar year. Appropriation for personal services of the public utilities and economic enterprises owned, operated and maintained by the City shall not be included in the amount budgeted and in the computation of the maximum amount for personal services.

No official or employee shall be entitled to a salary rate higher than the maximum fixed for his position or other positions or equivalent rank by applicable laws, rules and regulations issued thereon.

No local fund shall be appropriated to increase or adjust salaries or wages of officials and employees of the National Government, except as may be expressly authorized by law.

In cases of abolition of positions and creation of new ones resulting from the abolition of existing positions in the career service, such abolition or creation shall be made in accordance with pertinent provisions of the Rules and Regulations implementing R.A. 7160 and Civil Service Law, Rules and Regulations.

Positions in the official plantilla for career positions which are occupied by incumbents holding permanent appointments shall be covered by adequate appropriations.

No changes in designation or nomenclature of positions resulting in a promotion or demotion in a compensation shall be allowed, except when the position is a condance with Civil Service Law, Rules and Regulations.

#### SECTION 4. ITEMIZATION OF PERSONAL SERVICES.

The itemization of personal services in support of the appropriations herein authorized for personal services shall form part of this Ordinance and shall be governed by its provisions.

#### SECTION 5. USE OF APPROPRIATED FUNDS.

All funds appropriated for functions, projects and activities shall be released and used exclusively for the specific purposes for which they have been appropriated.

#### SECTION 6. AUTHORITY TO ADJUST APPROPRIATIONS.

Ordinance shall be passed authorizing any transfer on appropriations from one item to another. However, the City Mayor and the Presiding Officer of the Sangguniang Panlungsod are authorized to augment any item in their approved annual budget for their respective offices from savings in other items within the same expense classification of their respective appropriations.

# SECTION 7. TWENTY PERCENT (20%) DEVELOPMENT FUND.

The twenty percent (20%) Development Fund shall be utifized strictly for the projects provided in the approved Local Development Plan.

#### SECTION 8. CONTINGENCY FUND.

Except for expenses due to public utilities, rentals and insurance premiums a contigency reserve on the authorized 2025 appropriation for departmental Maintenance VandWother Operative Expenditures shall be provided for the purpose PURSUANT TO THE PROVISIONS OF REPUBLICACT NO. 7160

> a) No appropriation authorized for any department or office of the City Government of Valenzuela, Metropolitan Manila shall be available for expenditure until the head of each department or office shall have submitted to the City Budget Officer a Work and Financial Plan and Request for allotment of Funds showing the estimated amounts needed for each functions, activity or purpose for which the funds are to be expended during the applicable allotment period and until an Advise of Allotment for said request shall have been approved by the City Mayor, as herein provided. The work and Financial Plan and Request for Allotment shall be submitted to the City Budget Officer not less than twenty five (25) days prior to the beginning of the ensuing calendar year, Provided, that in case the annual budget is approved after December 6 of each calendar year, the Work and Financial Plan and Request for Allotment shall be submitted based on appropriations authorized.

In the Budget Ordinance of the immediately preceding calendar year as amended by a Supplemental Budget Ordinance, a revised Work and Financial Plan and Request for Allotment shall be submitted upon approval of the annual executive budget referred to Merein, showing quarterly allotment of the whole authorized appropriations for the department or office.

b) For the purpose of allotment system herein provided, each calendar year shall be divided into four (4) quarterly allotment periods, beginning on the first day of January, April, July and October, respectively.

c) The City Mayor may require neads of departments offices to revise their Financial Plan and of Requestion Allotment the Local Treasurer's notification and certification that the realized income is less than what is estiated in the annual/supplemental budget or that additional income is realized.
